In planning and performing our audit of the financial statements of the Matching Fund Special Purpose Securitization Corporation (the "Corporation"), a blended component unit of the Government of U.S. Virgin Islands, for the year ended September 30, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered the Corporation's internal control over financial reporting (internal control) as a basis for designing our auditing procedures for the purpose of expressing our opinion on the financial statements but not for the purpose of expressing an opinion on the effectiveness of the Corporation's internal control. Accordingly, we do not express an opinion on the effectiveness of the Corporation's internal control.

Our consideration of internal control was for the limited purpose described in the second paragraph of this letter and would not necessarily identify all deficiencies in internal control that might be significant deficiencies or material weaknesses. We did not identify any deficiencies in internal control that we consider to be material weaknesses, as defined above.

As a result of our observations of the Corporation's significant accounting policies and procedures and certain business, financial, income tax, and administrative practices, we suggest you consider the following:

Use of Excel for Accounting Records

During our audit of the financial statements for the period ended September 30, 2024, it was observed that the Corporation primarily maintains its accounting records using Microsoft Excel. While Excel is acknowledged for its versatility in facilitating a range of analytical and data management tasks, it is important to note that utilizing it as the main tool for comprehensive accounting record-keeping presents certain risks and limitations.

We are pleased to note that management is already in the process of transitioning to a more sophisticated accounting system. In light of our findings, we strongly support this transition, as it will enhance the integrity, efficiency, and reliability of the Corporation's financial reporting processes.
